

Level Funding for Legal Aid!

Good news! Today, Governor Patrick signed the FY11 state budget into law with level funding of [\\$9.5 million for MLAC](#).

From the beginning of our legislative funding campaign in the fall, we have hammered the message about the unprecedented IOLTA decline and the devastation that has been wrought on Massachusetts civil legal aid programs. And the message seems to have been heard. With your help, we convinced the Governor, the House, the Senate, the Conference Committee and the Governor (for a second time) that any reduction in the state appropriation would compound the funding crisis that you have been facing all year. Thank you for being an integral part of our campaign - we couldn't do it without you!

National Consumer Law Center

In *Jerman v. Carlisle et al.*, the United States Supreme Court's recent decision interpreting the federal Fair Debt Collection Practices Act, the court ruled that a debt collector does not have a bona fide error defense for mistakes of law. The favorable ruling was supported by an *amicus* brief from NCLC, and NCLC's Fair Debt Collection manual was cited twice in the opinion by Justice Sotomayor and once in the concurrence of Justice Breyer.

NCLC welcomes five summer fellows: **Pia Winston** (Mikels Fellowship from William & Mary Law School, to honor Richard Mikels), **Rachel Rothman** (Eble Summer Fellowship), **Shamis Beckley**, **Amanda Howell** and **Ana Lucia Hurtado**. Where's my desktop?

To quickly minimize all active windows and get to your Desktop, press the Windows logo key on your keyboard and either the letter M (to minimize the current window) or the Letter D (to reach Desktop).
