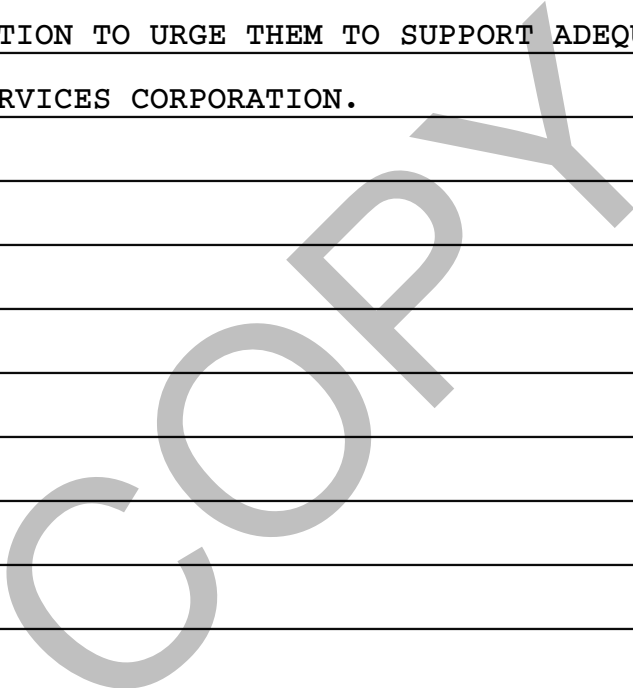

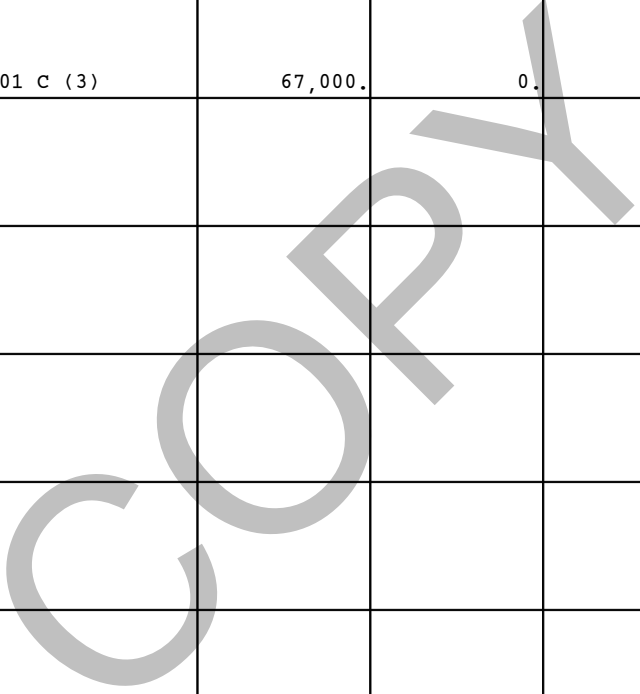

THESE ARE INDIVIDUALS WHO HAVE WORK EXPERIENCE WITH LEGAL AID PROGRAMS AND BACKGROUNDS IN PROGRAM EVALUATION. THEY ASSESS PROGRAM OPERATIONS AGAINST A FRAMEWORK OF PERFORMANCE STANDARDS DEVELOPED BY MLAC (BASED ON THE AMERICAN BAR ASSOCIATION (ABA) STANDARDS) THAT FOCUS ON THE FOLLOWING AREAS:

1. STRATEGIC AND COLLABORATIVE PLANNING PARTNERSHIP
2. DEVELOPMENT AND UTILIZATION OF RESOURCES
3. CLIENT ACCESS
4. QUALITY ASSURANCE
5. EFFECTIVE MANAGEMENT AND ADMINISTRATION
6. GOVERNANCE

THE PEER REVIEWER REVIEWS THIS INFORMATION, PREPARES AND ADMINISTERS INTERVIEW PROTOCOLS, CONDUCTS A SITE VISIT TO THE PROGRAMS OFFICE(S), AND COMPILES A REPORT IDENTIFYING THE

PROGRAMS STRENGTHS, CHALLENGES AND RECOMMENDATIONS TO IMPROVE PERFORMANCE. THE INDIVIDUAL PROGRAM DIRECTORS REPORT ON WHETHER THEIR PROGRAMS HAVE IMPROVED BECAUSE OF PEER REVIEW WHILE MLAC HAS ALSO OBSERVED ORGANIZATIONAL SHIFTS SUCH AS INCREASED FUNDRAISING AND STAFF DIVERSITY.
