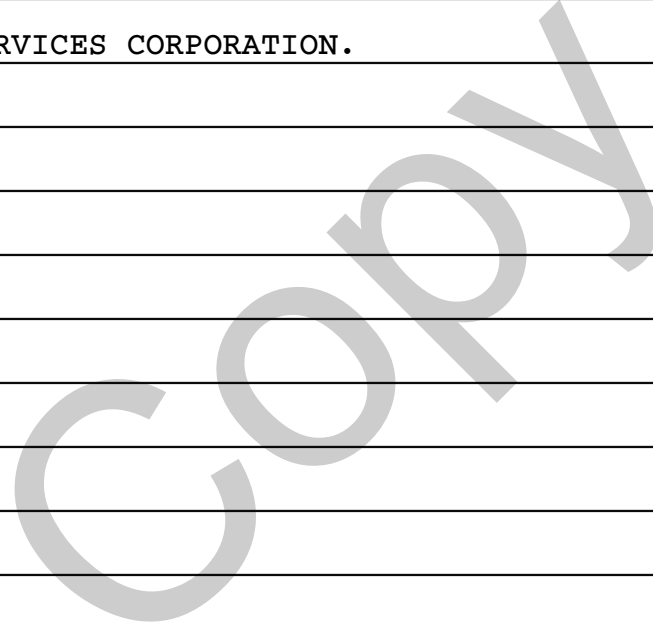

THEY ASSESS PROGRAM OPERATIONS AGAINST A FRAMEWORK OF PERFORMANCE STANDARDS DEVELOPED BY MLAC (BASED ON THE AMERICAN BAR ASSOCIATION (ABA) STANDARDS) THAT FOCUS ON THE FOLLOWING AREAS:

1. STRATEGIC AND COLLABORATIVE PLANNING PARTNERSHIP
2. DEVELOPMENT AND UTILIZATION OF RESOURCES

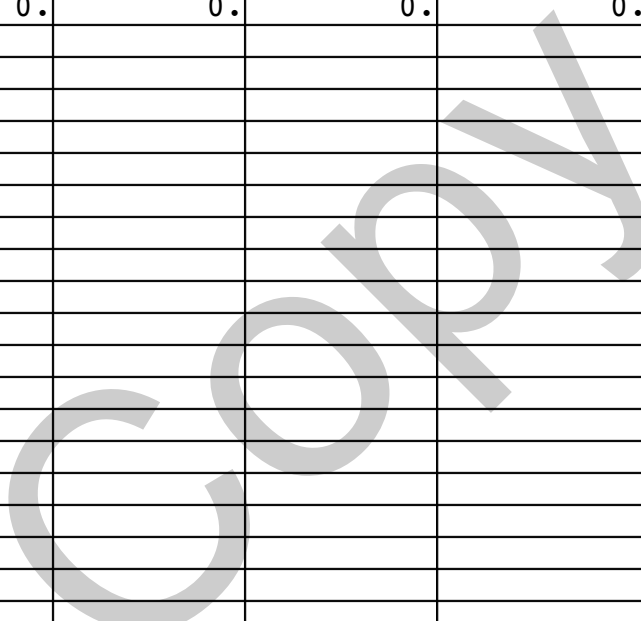
